Juniata County Conservation District Erosion & Sediment Pollution Control Program Review & Inspection Fee Schedule

All fees must be paid at the time of the Erosion & Sediment Pollution Control (E&S) Plan submission. Major modifications to an approved E&S Plan requiring a technical review will be subject to all review fees. Plan review fees include planning meetings, E&S plan reviews, construction meetings, and inspections.

FEE TYPES:

1. **E&S Plan Review Fee:** Checks made payable to "Juniata County Conservation District."
2. **Permit Fee:** Checks made payable to "Juniata County Conservation District Clean Water Fund."
3. **DEP Disturbed Acre Fee:** Checks made payable to "Commonwealth of PA Clean Water Fund." If a permit is required, this DEP Fee is also required. The check is forwarded to DEP by JCCD.
